**ORDINANCE NO. 2025-\_\_\_\_\_**

**AN ORDINANCE AMENDING CHAPTER 1, ARTICLE 3, DIVISION 47(F) OF THE  
VILLAGE OF GRANTFORK'S REVISED CODE OF ORDINANCES MODIFYING  
ESTABLISHED PLACES OF DEPOSIT FOR THE VILLAGE OF GRANTFORK, MADISON  
COUNTY, ILLINOIS**

**WHEREAS**, the Village of Grantfork has the authority granted to it by the Illinois Constitution and the Illinois Municipal Code; and

**WHEREAS**, Chapter 1, Article 3, Division 47(F) of the Village of Grantfork Revised Code of Ordinances ("Village Code") currently sets forth restrictions on approved places of deposit where the Treasurer of the Village is required to keep all funds and monies in his or her custody belonging to the Village; and

**WHEREAS**, the Village now desires to amend Chapter 1, Article 3, Division 47(F) to address a branding change of name for an existing approved location, as well as to modify existing approved places of deposit; and

**WHEREAS**, the Village Board of Trustees, after considerable deliberation and thought, has determined that it is in the best interest of the Village of Grantfork to amend Chapter 1, Article 3, Division 47(F) of the Village Code in the below manner.

**NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GRANTFORK, ILLINOIS, AS FOLLOWS:**

**SECTION 1: INCORPORATION:** The above recitals are incorporated by reference herein as express findings of fact.

**SECTION 2: AMENDMENT.** Chapter 1, Article 3, Division 47(F) is hereby amended to hereafter read as follows:

"(F) The following bank(s) are herewith designated as approved places of deposit where the Treasurer of the Village is required to keep all funds and monies in his custody belonging to the Village of Grantfork:

- (1) Bradford National Bank
- (2) Bank of Hillsboro/Constitution Bank
- (3) FCB Banks
- (4) Bank of Springfield (including in CDARS Program)
- (5) Illinois State Treasurer's Retirement Pool/Illinois Funds."

**SECTION 3. LIMITATIONS.** This Ordinance shall only apply to the specific articles, chapters, and sections as mentioned, and shall have no effect on any part of the remainder of the Village Revised Code not specifically set forth in this Ordinance.

**SECTION 4: SEVERABILITY OF PROVISIONS.** Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Ordinance, nor any part thereof, other than that part affected by such decision.

**SECTION 5: CONFLICTING ORDINANCES.** Any conflicting ordinances, code provisions or pertinent portions thereof in effect at the time this ordinance takes effect are hereby repealed. Nothing in this Ordinance shall impact any provisions of Chapter 1 of the Grantfork Revised Code not otherwise expressly modified herein, and all other provisions not modified shall remain in full force and effect.

**SECTION 6: EFFECTIVE.** This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

**SECTION 7:** Passed this 4th day of August, 2025 by the Village Board of Trustees of the Village of Grantfork, Madison County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.
