

**RESOLUTION NO. 25-07-01R**

**A RESOLUTION APPOINTING SYDNEY THOLE TO THE POSITION OF VILLAGE TRUSTEE FOR THE VILLAGE OF GRANTFORK, ILLINOIS**

**WHEREAS**, during the April 1, 2025 consolidated election, a position of Village Trustee for Grantfork was on the ballot, no candidate filed to run for said position, nor was any candidate elected to said position, thereby constituting a vacancy in a position of Village Trustee for Grantfork; and

**WHEREAS**, there are more than Twenty-Eight (28) months remaining in the term of office that is vacant, and the next scheduled general municipal election is more than 130 days from the date of this appointment, meaning that the appointment provided for herein shall stand until the next municipal election scheduled to occur April 6, 2027; and

**WHEREAS**, under the applicable provisions of the Illinois statutes, specifically 65 ILCS 5/3.1-10-50, the Village President may appoint a qualified individual to the vacant office with the advice and consent of the Village Board, said person to serve until the next regularly scheduled general municipal election as provided for herein, with the remainder of the term of office being placed on the April 6, 2027 consolidated election to run for a two (2) year term; and

**WHEREAS**, Sydney Thole is a resident of the Village of Grantfork, Illinois, is a qualified elector who has resided in the Village of Grantfork for a period in excess of one (1) year preceding the date of this appointment, is not in arrears in taxes or other indebtedness due to the municipality, and has not been convicted of any infamous crime, bribery, perjury, or other felony.

**NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GRANTFORK, ILLINOIS, AS FOLLOWS:**

**SECTION 1:** Sydney Thole is hereby found to be and deemed qualified for the position of Village Trustee for the Village of Grantfork, Illinois, and is hereby appointed to said position and shall continue to serve in this appointed capacity until her successor is confirmed following the April 6, 2027 election.

**SECTION 2:** This Resolution and the appointment made herein, shall be in effect upon its

passage, approval and publication as provided by law.

**SECTION 3:** Any and all Resolutions, sections or subsections of Resolutions in conflict herewith are hereby repealed.
